

IN THE MATTER OF THE ONTARIO HERITAGE ACT, R.S.O. 1990, CHAPTER 0.18, AND IN THE MATTER OF THE LANDS AND PREMISES LOCATED AT "157 QUEEN STREET SOUTH", IN THE CITY OF MISSISSAUGA, IN THE PROVINCE OF ONTARIO.

### NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that The Council of the Corporation of the City of Mississauga intends to designate the lands and buildings located at 157 Queen Street South in the City of Mississauga, in the Province of Ontario, as a property of architectural and historical significance under Part IV of The Ontario Heritage Act, R.S.O. 1990, c. 0.18, as amended.

#### REASONS FOR THE PROPOSED DESIGNATION:

**The Graydon-Atkinson House, 157 Queen Street South**, is proposed for heritage designation for reasons of its architectural and historical significance. The brick house, built circa 1895 by John Graydon, was designed in an L-shape plan, of the Gothic Revival style. Graydon was a local builder in the Streetsville area, as well as politician, School Board member, Justice of the Peace, and early supporter of the Credit Valley Railroad.
