

BY-LAW NUMBER...624-89

To designate the "Millworkers' Double House" located at 1605-07 Eglinton Avenue West, as being of historical, architectural and contextual importance.

WHEREAS The Ontario Heritage Act, R.S.O. 1980, Chapter 337, authorizes the Council of a municipality to enact by-laws to designate real property including all the buildings and structures thereon, to be of historic or architectural value or interest; and


WHEREAS Notice of Intention to so designate the "Millworkers' Double House" located at 1605-07 Eglinton Avenue West, in the City of Mississauga, has been duly published and served, and no notice of objection to such designation has been received by the Council of the Corporation of the City of Mississauga; and


WHEREAS the reasons for the said designation are set out as Schedule 'B' hereto;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. That the real property, more particularly described in Schedule 'A' hereto, known as the "Millworkers' Double House" located at 1605-07 Eglinton Avenue West, be designated as being of historical, architectural and contextual importance under Part IV of The Ontario Heritage Act, R.S.O. 1980, c. 337.
2. That the City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property, and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Mississauga.
3. That the City Solicitor is hereby directed to register a copy of this by-law against the subject property.

SCHEDULE 'B' TO BY-LAW NO. 624-89

SHORT STATEMENT OF THE REASONS FOR
THE PROPOSED DESIGNATION

Historically, the house located at 1605-07 Eglinton Avenue West is one of the two remaining structures that represents the 43 identical structures built circa 1850 to house the workers of the Toronto Woollen Mills, Streetsville. The mill was owned and operated by the Barber Brothers who founded the mill in 1843. The mill, associated buildings, millworkers houses and their own homes comprised what was known as Barberville, located by Eglinton Avenue West, on the south, Mississauga Road to the west and Barberville Road to the north.

Architecturally, this house is a typical example of mid-nineteenth century low-cost housing commonly referred to as workman's cottages. The residence also represents a particular type of dwelling, the double house, reflecting its possible use as a family unit. The frame structure has a mildly pitched gable roof, boxed eaves and classical cornice returns. Each half of the symmetrical facade has a centre door flanked by a window on either side. The original exterior finish was stucco. There is a window in each gable end and a single window in the dormer above each door.

Contextually, the house at 1605-07 Eglinton Avenue West is in its original location, which provides an historical context to the property in relation to the mill, the reason for its being built and along with the house at 1595-97 Eglinton Avenue West provides a streetscape of two related structures which will continue to provide a real symbol of what was once the thriving community of Barberville.
