NOTICE

IN THE MATTER OF THE ONTARIO HERITAGE ACT, R.S.O. 1990, CHAPTER 0.18, AND IN THE MATTER OF THE LANDS AND PREMISES, KNOWN AS "KINDREE FAMILY CEMETERY", LOCATED AT 3790 DERRY ROAD WEST, IN THE CITY OF MISSISSAUGA, IN THE PROVINCE OF ONTARIO.

NOTICE OF INTENTION TO DESIGNATE

The Kindree Family Cemetery, 3790 Derry Road West, is recommended for heritage designation for reasons of its historical significance. This small cemetery is believed to include seven graves, all children of the Kindree Family, buried in this location from 1829 to circa 1840. The internments at this site were the children of Nathan and Mary Kindree who settled in the area on a 100 acre land grant in 1819. The family moved a short distance and bought the subject property in 1823, which remained in the Kindree family until 1877. The burials are marked by four severely deteriorated stone grave markers.

The area around the cemetery was at one time protected by decorative fencing. At the time of designation the true extent of the cemetery is not known. Further research through archaeological investigations to confirm the number and location of internments will be necessary.
