

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the City of Brampton intends to designate property, being the concrete bowstring arch bridge on Creditview Road north of Steeles Avenue West in the City of Brampton, in the Province of Ontario, as a property of historic, architectural and contextual significance under Part IV of the Ontario Heritage Act, R.S.O. c.O. 18.

REASONS FOR THE PROPOSED DESIGNATION


The concrete bowstring arch bridge on Creditview Road north of Steeles Avenue which spans the Credit River has stood for almost 80 years as an example of a type of bridge construction (concrete bowstring arch bridge) which has played an important role in the history of transportation in the Province of Ontario. In addition to being a significant landmark in the area and a reminder of the City's rich history, the bridge is an increasingly rare example of this type of structure in Ontario.
