BY-LAW NUMBER **479-87**

A by-law to repeal By-law No. 700-78, a by-law designating the lands and premises known municipally as the Leslie Log House, Mississauga Road, North of Derry Road West, and to designate the Leslie Log House and the lands known as part of Block 7, Plan 43M-589, being Part 1, Plan 43R-14211 in the City of Mississauga in the Regional Municipality of Peel;

WHEREAS the Council of The Corporation of the City of Mississauga enacted By-law No. 700-78 on the 30th day of October, 1978 designating a portion of the lands and buildings known as the Leslie Log House, as a property of historic or architectural value or interest under the Ontario Heritage Act;

AND WHEREAS the lands being the subject matter of By-law No. 700-78 were described as part of Lot 12, Concession 5, West of Hurontario Street being Part 1 on Plan 43R-6325;

AND WHEREAS part of the lands described in By-law No. 700-78 are not required for the preservation of the Leslie Log House, and may be used for development by the owners thereof;

AND WHEREAS it is intended to repeal By-law No. 700-78, and thereupon to enact a new by-law designating the Leslie Log House containing a description of the lands remaining to be associated with the Leslie Log House, and which are described as part of Block 7, Plan 43M-589 being Part 1 Plan 43R-14211 in the City of Mississauga in the Regional Municipality of Peel;

AND WHEREAS the Leslie Log House is recommended for designation on the architectural grounds that not only is it one of the earliest structures still standing in the City of Mississauga today, but also as a rare surviving example of log construction. Despite such changes as the removal of the clapboard, it is still a good example of a vernacular building with some stylistic characteristics in its Georgian entranceway. Built about 1825-1826 by John Leslie Sr., the house was lived in by the same family for almost seventy years, thus reflecting the usual pattern of early settlement;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. That By-law No. 700-78 of The Corporation of the City of Mississauga enacted on the 30th day of October, 1978, be and is hereby repealed.
2. That the Lands and premises known municipally as the Leslie Log House located on Mississauga Road, North of Derry Road West, and being described as part of Block 7 according to Registered Plan 43M-589, being Part 1, Plan 43R-14211, in the City of Mississauga in the Regional Municipality of Peel, be and are hereby designated as a property within the municipality to be of historic or architectural value or interest.
