## NOTICE

IN THE MATTER OF THE ONTARIO HERITAGE ACT, R.S.O. 1980, CHAPTER 337, AND IN THE MATTER OF THE LANDS AND PREMISES KNOWN AS LISLEHURST (PRINCIPAL'S RESIDENCE AT ERINDALE COLLEGE, LOCATED AT THE NORTH END OF THE CAMPUS), MISSISSAUGA ROAD NORTH, IN THE CITY OF MISSISSAUGA, IN THE PROVINCE OF ONTARIO.

### NOTICE OF INTENTION

#### TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Mississauga decided to designate "Lislehurst", as a property of architectural importance and historical associations under The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

#### REASONS FOR THE PROPOSED DESIGNATION:

Lislehurst is recommended for recognition on the Mississauga Heritage Inventory and for designation under the Ontario Heritage Act for its architectural importance and historical associations. Built in 1885 of Credit Valley stone and remodelled and renovated by Reginald Watkins in 1928 in a Tudor revival style. Lislehurst is a fine example of the early 20th century, interest and revival of historic architectural styles. Architectural features of note include the Credit Valley stone walls, tall windows, steep gables and vertical lines of the east wing. Historically, the house was built by Herbert Harrie Schreiber and is the last remaining of three homes built by the Schreiber family in the area. Today, the house serves as a home to the Principal of Erindale College and is a landmark on the Erindale College campus.)

Notice of objection to the designation may be served on the City Clerk within thirty days of June 26, 1985.
