## THE CORPORATION OF THE CITY OF MISSISSAUGA BY-LAW NUMBER 0204-2010

A By-law to amend By-law 0158-2010, being a By-law to repeal By-law 0386-2005 a Heritage Designation By-law for the property located at 1760 Bristol Road West as being of historical, architectural and contextual significance

WHEREAS the Council of The Corporation of the City of Mississauga enacted By-law 0158-2010 on the 26<sup>th</sup> day of May, 2010, repealing By-law 0386-2005, being a By-law for the property located at 1760 Bristol Road West, legally described as Part of Lots 1, 4, 5 and 7, Plan STR-5, and Part of Lot 3, Concession 4, west of Hurontario Street, designated as Parts 2, 4, 6, 7 and 8 on Reference Plan 43R-18274 (the "Property");

AND WHEREAS the reference to the Parcel Identification Number ("PIN") in the second recital of By-law 0158-2010 is inapplicable;

NOW THEREFORE the Council of The Corporation of the City of Mississauga hereby ENACTS as follows:

- 1. That the phrase "as shown on PIN 13196-0631 (LT);" be and is hereby deleted from the second recital of By-law 0158-2010.
- 2. That the City Clerk is hereby authorized to cause a copy of this By-law to be served upon the owner of the Property, and upon the Ontario Heritage Trust.
