The Heritage Advisory Committee on April 27, 2010 considered the above captioned matter and recommended the following:

That the City withdraw the notice of intention to designate the Hamilton House located at 6588 Ninth Line (lands annexed from Milton) initiated by the Town of Milton under the Ontario Heritage Act, and that the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
