TAKE NOTICE that the Council of the Corporation of the Town
of Cobalt intends to designate the property,
including lands and buildings, at the following municipal address
as a property of architectural and/or historical value or interest
under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

Municipal Address: 7 Prospect Avenue, Cobalt. Ontario.

Reasons for the Proposed Designation:

The Bank of Ottawa building is recommended for designation for architectural reasons. Constructed in 1913, this charming two storey structure is built in a Medeval style unique in the Town of Cobalt. The Medeval motif is carried out on the pressed brick facade with the use of a concrete "dressed stone" base, quoined "stone" edging around the windows and door, a ground floor window under a segmentally arched "stone" heading, a crenellated drip stone and side scrolled transom light over the door, a centred second floor quintuple window topped with a continuous "stone" heading band, and a bracketed "dressed stone" cornice. This building presents a unique architectural facet of the first decade of the Town of Cobalt.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Cobalt before the 26th. day of October, 1978.
