TAKE NOTICE that the Council of the Corporation of the Town  
of Cobalt intends to designate the property,  
including lands and buildings, at the following municipal address  
as a property of architectural and/or historical value or interest  
under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

Municipal Address: 19 Prospect Avenue, Cobalt, Ontario.

Reasons for the Proposed Designation:

The Northern Ontario Light and Power Company building is recommended for designation for architectural and historical reasons. This two storey frame and clapboard building is typical of many early Cobalt "boomtown" commercial and residential buildings, of which so few have survived. The "boomtown" feeling is enhanced by the rectangular front, flat roof, irregular placing of windows, and two storey front gallery, although this is of later construction. This building, with its mixture of commercial and residential use, is an integral part of that fabric that remains of early Cobalt.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Cobalt before the 26th. day of October, 1978.
