TAKE NOTICE that the Council of the Corporation of the Town
of Cobalt intends to designate the property,
including lands and buildings, at the following municipal address
as a property of architectural and/or historical value or interest
under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

Municipal Address: 30 Silver Street, Cobalt, Ontario.

Reasons for the Proposed Designation:

The Classic Theatre, built in 1926, is recommended for designation for architectural and historical reasons. It retains the simple facade, with the large first floor display windows, inset door, and marquee, of the typical 1920's cinema. The second floor, with its inset panel and three windows, provides geometric design interest derived from the contemporary Art Deco. The Classic Theatre is the lone survivor of the many theatres, essential to the morale of a mining camp, that entertained early Cobalt and thus presents a unique and integral facet of Cobalt's historical context.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Cobalt before the 26th. day of October, 1978.
