THE CORPORATION OF THE CITY OF MISSISSAUGA BY-LAW NUMBER . COHS . 2012

A By-law to designate the Erindale Community Hall located at 1620 Dundas Street West as being of cultural heritage value or interest

WHEREAS the *Ontario Heritage Act*, R.S.O. 1990, Chapter O.18, as amended, authorizes the Council of a municipality to enact By-laws to designate real property including all the buildings and structures thereon, to be of cultural heritage value or interest;

AND WHEREAS Notice of Intention to designate the Erindale Community Hall located at 1620 Dundas Street West, in the City of Mississauga, has been duly published and served, and no notice of objection to such designation has been received by the Clerk of The Corporation of the City of Mississauga;

NOW THEREFORE the Council of The Corporation of the City of Mississauga hereby ENACTS as follows:

- That the property, including all the buildings and structures thereon, known as the Erindale Community Hall located at what is municipally known as 1620 Dundas Street West, in the City of Mississauga, and legally described in Schedule 'A' attached hereto, is hereby designated as being of cultural heritage value or interest under Part IV of the *Ontario Heritage Act*, R.S.O. 1990, Chapter O.18, as amended.
- 2. That the reasons for designating the property known as the Erindale Community Hall located at 1620 Dundas Street West, in the City of Mississauga, under Section 1 of this By-law, are duly set out in Schedule 'B'.
- 3. That the City Clerk is hereby authorized to cause a copy of this By-law to be served upon the owner of the aforesaid property, and upon the Ontario Heritage Trust and to cause notice of this By-law to be published in a newspaper having general circulation in the City of Mississauga.
- 4. That Schedules 'A' and 'B' form an integral part of this By-law.
- That the City Solicitor is hereby directed to register a copy of this By-law against the property located at 1620 Dundas Street West as described in Schedule 'A' in the proper land registry office.

DESIGNATION STATEMENT Erindale Community Hall, 1620 Dundas Street West

Description of Property

Erindale Community Hall is a privately owned and community managed rectangular facility located on the southwest corner of Dundas Street and Mindemoya Road.

Statement of Cultural Heritage Value or Interest

Erindale Community Hall is a rare example of a surviving purpose-built community hall in Mississauga.

Erindale Community Hall has direct associations with the Erindale community and beyond. It yields information that contributes to an understanding of Erindale.

Erindale Community Hall is important in defining, maintaining and supporting the character of the area. It is physically, functionally, visually and historically linked to its surroundings. The hall is a local landmark.

Description of Heritage Attributes

Key attributes that reflect Erindale Community Hall's physical/design value:

- its traditional long rectilinear hall form with a traditional roof and porch
- features indicative of its age including:
 - o Credit Valley stone material
 - o traditional window and door openings
 - o window sills and voussoirs
 - o exposed purlins
 - o shape, form and material of chimney
 - o venting in the gable ends
 - location close to, and with main entrance facing and open to, Dundas Street West

Key attributes that reflect Erindale Community Hall's historical/associative value:

- its location in Erindale and along its main thoroughfare
- its Credit Valley stone

Key attributes that reflect Erindale Community Hall's contextual value:

- · its location in Erindale and along its main thoroughfare
- its visibility from Dundas Street West and Mindemoya Road
