TAKE NOTICE that the Council of the Corporation of the Town  
of Cobalt intends to designate the property,  
including lands and buildings, at the following municipal address  
as a property of architectural and/or historical value or interest  
under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

Municipal Address: 66 Nickel Street, Cobalt. Ontario.

Reasons for the Proposed Designation:

The Dr. McLaren House is recommended for designation for architectural reasons. Built Circa 1908 by Dr. McLaren, one of Cobalt's pioneer physicians, it is the best example of the Queen Anne Shingle style in Cobalt, with its shingled gable ends and dormer, first storey brick, multipaned windows, bay window, intricate eaves detailing and now enclosed inset corner porch. The handsome structure adds much to the Cobalt townscape.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Cobalt before the 26th. day of October, 1978.
