TAKE NOTICE that the Council of the Corporation of the Town
of Cobalt intends to designate the property,
including lands and buildings, at the following municipal address
as a property of architectural and/or historical value or interest
under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

Municipal Address: Temiskaming Testing Laboratories, Presley Street.
Cobalt, Ontario.

Reasons for the Proposed Designation:

The Second Town Hall is recommended for designation for architectural and historical reasons. Constructed in a vernacular style in 1914, it is the only one of the three Town Halls to have preserved its architectural integrity. This massive brick structure, with its irregular three-storey lake side and intricately ordered Presley Street facade, was a highly ambitious project for the people of Cobalt; it was an expression of their pride and confidence in the town. As such, it is an integral part of the fabric that remains of early Cobalt.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Cobalt before the 26th. day of October, 1978.
