## Notice of Amendment of Heritage By-laws

The Town of Collingwood has three heritage designation by-laws which require amendment due to the change in legal description of the designated properties.

- 1. 291 Third St., Heritage designation by-law 90-77, the legal description required amendment due to the creation by severance of two properties (153 & 155 Cedar St.) which were originally part of the property described and designated under by-law 90-77. The amending by-law is 2012-103, see attached.
- 2. 275 Third St., Heritage designation by-law 83-45, the legal description required amendment due to the sale of a whole lot (Lot 27) which was part of the originally designated parcel. The amending by-law is 2012-102, see attached.
- 3. 125 Napier St., Heritage designation by-law 2010-019, the legal description required amendment to the creation by severance of four properties (123 & 145 Napier St., 40 & 60 West St), which were part of the originally designated parcel. The amending by-law is 2012-104, see attached.

The Town of Collingwood passed the amending by-laws under Section 30.1 of the Ontario Heritage Act at their Council meeting held September 10, 2012.

Enclosed please find a copy of the amending by-laws as required. Notice will also be given to the owners of the properties affected as per the Ontario Heritage Act.

## BY-LAW No. 2012-104 OF THE CORPORATION OF THE TOWN OF COLLINGWOOD



BEING A BY-LAW TO AMEND BY-LAW NO. 2010-019 TO CORRECT THE LEGAL DESCRIPTION OF PROPERTY COMMONLY KNOWN AS 125 NAPIER STREET, COLLINGWOOD

WHEREAS section 30.1 of the Ontario Heritage Act, R.S.O. 1990, c. O.18, as amended, authorizes the council of a municipality to amend a by-law designating property under section 29 of the Act by the municipality;

**AND WHEREAS** the Council of The Corporation of the Town of Collingwood passed By-law No. 2010-019, being a by-law to designate property commonly known as 125 Napier Street as being of historical or architectural value or interest, under s. 29 of the Act;

**AND WHEREAS** the legal description set out in By-law No. 2010-019 has since changed due to a severance of the original property creating four (4) new parcels;

**AND WHEREAS** the Council off The Corporation of the Town of Collingwood seeks to correct the legal description of the property designated under section 29 of the Act;

**AND WHEREAS** the Council of The Corporation of the Town of Collingwood has given the owner of the designated property written notice of the proposed amendment in accordance with subsection 30.1 (4) of the Act;

**AND WHEREAS** no Notice of Objection to the proposed amendment has been served on the Clerk of The Corporation of the Town of Collingwood;

**AND WHEREAS** a copy of this By-law shall be provided to the owner of the property and the Trust and shall be registered against the property in the proper land registry office;

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF COLLINGWOOD HEREBY ENACTS AS FOLLOWS:

- THAT By-law No. 2010-019, a by-law designating 125 Napier Street as being historical or having architectural value or interest, be amended as follows:
  - Delete the legal description provided in the body and Schedule "A" of By-law No. 2010-019 being:

"Lots 3, 4 & 5, E/S Napier Street, Plan 282, Town of Collingwood, County of Simcoe"

AND

"PIN 58292-0125 (R)

Lot 3 E/S Napier Street, Plan 55, AKA Plan 282, Town of Collingwood; Lot 4 E/S Napier Street, Plan 282, Town of Collingwood; Lot 5 E/S Napier Street, Plan 282, Town of Collingwood, County of Simcoe"

and replacing it with the following:

"PIN 58292-0224 (LT)

Part of Lots 3, 4 and 5 E/S Napier Street, Plan 282 Collingwood; designated as Part 3, Plan 51R-38486, Town of Collingwood, County of Simcoe"

2. THAT the heritage designation does not apply to the newly created parcels legally described below and now commonly known as 123 Napier Street, 40 West Street, 145 Napier Street and 60 West Street:

PIN 58292-0220 (LT)

Part of Lot 5 E/S Napier Street, Plan 282 Collingwood; designated as Part 1, Plan 51R-38486; Town of Collingwood, County of Simcoe

PIN 58292-0221 (LT)

By-law 2012-104 Amending Heritage Designation – 125 Napier Street

Part of Lot 5 E/S Napier Street, Plan 282 Collingwood; designated as Part 2, Plan 51R-38486; Town of Collingwood, County of Simcoe

PIN 58292-0222 (LT)
Part of Lot 3 E/S Napier Street, Plan 282 Collingwood; designated as Part 4, Plan 51R-38486; Town of Collingwood, County of Simcoe

PIN 58292-0223 (LT)

Part of Lot 3 E/S Napier Street, Plan 282 Collingwood; designated as Part 5, Plan 51R-38486; Town of Collingwood, County of Simcoe

3. THAT this By-law shall come into full force and effect on the final date of passage hereof.
