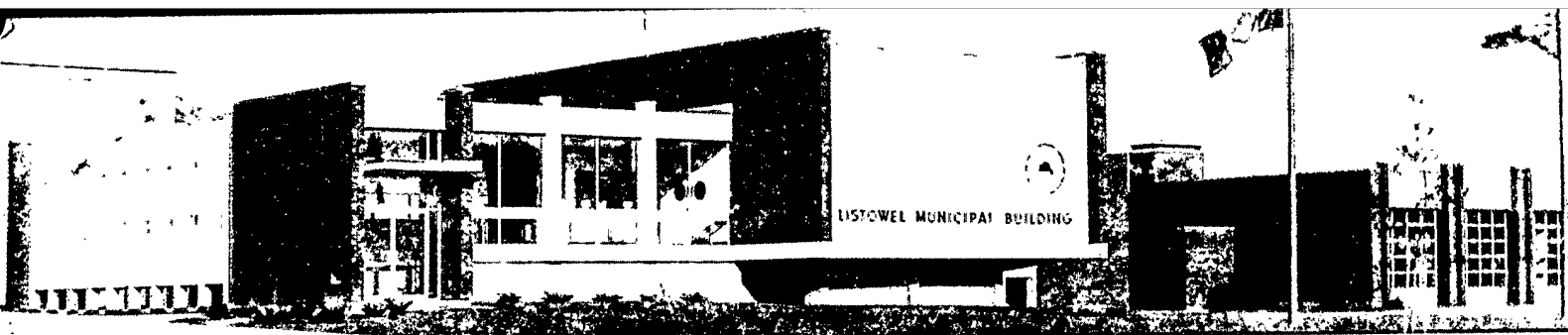

CORPORATION OF THE TOWN OF LISTOWEL

BY-LAW NO. 91-15

Being a By-Law to designate the property known municipally as 580 Main Street West as being of architectural value or interest.

Whereas section 29 of The Ontario Heritage Act, 1974 authorizes the Council of the municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

Whereas the Council of the Corporation of the Town of Listowel has caused to be served on the owners of the lands and premises known as The Pumphouse at 580 Main Street West and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

Whereas the Conservation Review Board has held a hearing to determine whether the property in question should be designated and reported its findings of fact and recommendations to the Council; and

Whereas the Council has considered the report of the Conservation Review Board;


Therefore the Council of the Corporation of the Town of Listowel enacts as follows:

1. There is designated as being of architectural and historical value or interest that part of the building known as The Pumphouse at 580 Main Street West, more particularly described in the reasons in Schedule A hereto.
2. The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A hereto in the Perth County land registry office.
3. The Administrator, Clerk-Treasurer is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

READ A FIRST AND SECOND TIME this 3rd day of April, 1991.

READ A THIRD TIME AND FINALLY PASSED this 15th day of April, 1991.
