NOTICE OF PASSING OF BY-LAWS

TAKE NOTICE THAT the Council of the Corporation of the Township of Norwich has passed By-Law No. 67-89 to designate the following property as being of architectural and historical value or interest under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337:

A. LOCATION: KNOX PRESBYTERIAN CHURCH, Lot 565, Plan 955, former Village of Norwich

REASON FOR DESIGNATION:

The first congregation was established in 1849, the present Church was built in 1879. The Church, built of white clay brick, of gable-end design has many fine details. The architect and builder are unknown.

The front facade is ornamented with four brick buttresses and crenellated brickwork beneath the eaves. The double main doors located at each side of the facade form gothic arches and are constructed of vertical tongue and groove boards on the exterior and horizontal planking on the interior. They are hung with ornamental ironwork. The elaborate wooden and brick surrounds incorporate a rope design, labelled with relief carvings of wooden leaf motifs.

Above the doors are double trefoil lancet windows capped with a cruciform window of coloured glass and a gothic brick surround. These are the same as the four second storey side windows of the Church which are located between five buttresses.

The centre panel of the front facade, on the ground level, contains four narrow double hung windows with a common sill and joined gothic surrounds. Above is an elaborate window formed of a pair of the gothic side windows surmounted by a coloured glass surround. Between the two central windows is a row of ornamental brick design.

The roof is of slate and the interior is furnished with the original plain elm pews.

THE CORPORATION OF THE TOWNSHIP OF NORWICH

BY-LAW 67-89

BEING A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS THE KNOX PRESBYTERIAN CHURCH LOT 565, PLAN 955, FORMER VILLAGE VILLAGE OF NORWICH, AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST.

WHEREAS, SECTION 29 of The Ontario Heritage Act, 1980, authorizes the council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS, the Council of the Corporation of the Township of Norwich has caused to be served on the owners of the lands and premises known as THE KNOX PRESBYTERIAN CHURCH, Lot 565, Plan 955, former Village of Norwich, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks;

AND WHEREAS, no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

THEREFORE, the Council of the Corporation of the Township of Norwich enacts as follows:

- There is designated as being of architectural and historical value or interest the real property known as The Knox Presbyterian Church, Lot 565, Plan 955, former Village of Norwich, more particularly described in SCHEDULE A, hereto attached.
- 2. The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A hereto in the proper land registry office.
- 3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

DESCRIPTION

ALL AND SINGULAR THAT CERTAIN PARCEL OR TRACT OF LAND AND PREMISES SITUATE lying and and being in the Village of Norwich in the County of Oxford in the Province of Ontario containing by a measurement of thirty four thousand eight hundred and seventy five square links be the same more or less;

Being composed of Village Lot Number Ten on the South side of Main Street and Village Lot Number Ten on the North side of Front Street in the said Village of Norwich according to a map or plan of the said Village drawn by the late John A. Tidey, P.L.S. and deposited in the Registry Office for the said County of Oxford the same being a part of Lot Number Eight in the Fifth Concession of the Township of North Norwich.
