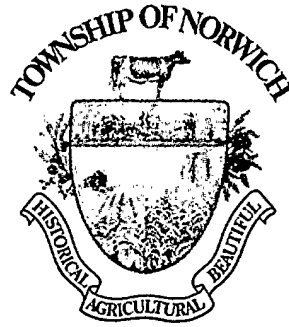

THE CORPORATION OF THE TOWNSHIP OF NORWICH

BY-LAW NO. 51-92

BEING A BY-LAW TO REPEAL
BY-LAW NO. 40-86.

WHEREAS By-Law No. 40-86 was duly passed on the 14th day of July, 1986, to designate the property known municipally as THE SNYDER-DEER HOUSE, South Part Lot 15, Concession 1, former Township of North Norwich, as being of architectural and historical value or interest;

AND WHEREAS, as a result of approval of application for consent affecting the subject property, By-Law No. 42-92 was duly passed on the 13th day of October, 1992, to designate the Snyder-Deer House;

AND WHEREAS, it is now deemed necessary and expedient to repeal By-Law No. 40-86;

NOW THEREFORE, the Municipal Council of the Corporation of the Township of Norwich enacts as follows:

1. That By-Law No. 40-86 duly passed on the 14th day of July, 1986, be hereby repealed.
