



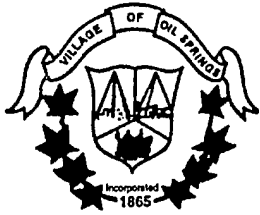

THE CORPORATION OF THE VILLAGE OF OIL SPRINGS

BY-LAW NUMBER 354 OF 2003

A by-law to designate the property municipally known as the Langbank Post Office and located at the Oil Museum of Canada, 2423 Kelly Road, in the Village of Oil Springs, as being of architectural and historical value or interest.

WHEREAS Section 52 of the Ontario Heritage Act, 1920, R.S.O. Chapter 6.18, authorizes the Council of a Municipality to enact By-Laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest, and,

WHEREAS the Council of the Corporation of the Village of Oil Springs has deemed the Langbank Post Office located at the Oil Museum of Canada, 2423 Kelly Road, in the Village of Oil Springs, Ontario, Plan 2, Range 18, Lot 16 and upon the Ontario Heritage Foundation, notice of intention to be published in the same newspaper having general circulation in the municipality for three weeks; and

NOW THEREFORE the Council of the Corporation of the Village of Oil Springs Hereby Enacts As Follows:

1. This is designated as being of architectural and historical value or interest of the real property as the former Langbank Post Office, located at the Oil Museum of Canada, 2423 Kelly Road, in the Village of Oil Springs, Province of Ontario, more particularly described as Plan 2, Range 18, Lot 16 hereto.
2. The Solicitor is hereby authorized to cause a copy of this By-Law to be registered against the property described as Plan 2, Range 18, Lot 16 in the proper land registry office.
3. The Clerk Treasurer is hereby authorized to cause a copy By-Law on the Ontario Heritage Foundation and to cause notice of the passing of this By-Law to be published in the same newspaper having general circulation in the Municipality.

By-Law read a First and Second Time this 2nd day of December, 2003.

By-Law read a Third Time and Finally Passed this 2nd Day of December, 2003.
