THE CORPORATION OF THE VILLAGE OF OIL SPRINGSBY-LAW NUMBER 462 OF 2007

**A BY-LAW TO DESIGNATE THE PROPERTY MUNICIPALLY KNOWN AS  
4596 OIL SPRINGS LINE, THE COMMUNITY HALL, IN THE VILLAGE OF OIL  
SPRINGS, AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR  
INTEREST.**

WHEREAS Section 52 of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18 s.29.1 authorizes the Council of a Municipality to enact By-Laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest, and


WHEREAS the Council of the Corporation of the Village of Oil Springs has caused to be served on the owner of the lands and premises of 4596 Oil Springs Line, in the Village of Oil Springs, and upon the Ontario Heritage Foundation, notice of intention to be published in the same newspaper having general circulation in the municipality for one week; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk Treasurer of the Municipality;

NOW THEREFORE the Council of the Corporation of the Village of Oil Springs hereby enacts as follows:

1. This is designated as being of architectural and historical value or interest of the real property as 4596 Oil Springs Line, in the Village of Oil Springs, Province of Ontario, Con 3 Lot 16 Con 3 E Pt Lot 16 Frmlly Pt Lt 22 Lts 23 & 24 Pt Lt 28 Lts 29-32 Incl Pl 2 Irr, known as the Community Hall.
2. The Municipal Clerk Treasurer is hereby authorized to cause a copy of this By-law to be registered against the property described above hereto in the proper land registry office.
3. The Clerk Treasurer is hereby authorized to cause a copy of this By-Law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality.
