

COUNTY OF PRINCE EDWARD

BY-LAW NO. 1528

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS LOT 22 ACCORDING TO R.W. HERMAN'S REGISTERED PLAN NUMBER 3 OF THE TOWNSHIP OF SOPHIASBURG IN THE COUNTY OF PRINCE EDWARD AS BEING OF HISTORICAL VALUE AND INTEREST.

WHEREAS Section 29 of the Ontario Heritage Act, Chapter 337 R.S.O. 1980 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical interest and value.

WHEREAS the Council of the Corporation of the County of Prince Edward has caused to be served on the owners of the lands and premises known as the Sophiasburg Township Hall, Lot 22 according to R.W. Herman's Registered Plan number 3 of the Township of Sophiasburg and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the municipality once for 3 consecutive weeks and;

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality.

THEREFORE THE CORPORATION OF THE COUNTY OF PRINCE EDWARD enacts as follows:

1. There shall be designated as being of historical value and interest the real property known as "The Sophiasburg Township Hall" Lot 22 according to R.W. Herman's Registered Plan number 3 of the Township of Sophiasburg in the County of Prince Edward.
2. The County Clerk is hereby authorized to cause a copy of this by-law to be registered against the property described above.
3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause a notice of the passing of this by-law to be published in a newspaper having general circulation in the municipality once for each of three consecutive weeks.

READ A THIRD TIME AND FINALLY PASSED at Picton, Ontario this 18th day of January, 1983.
