

AND, IN THE MATTER OF THE LANDS AND PREMISES KNOWN MUNICIPALLY AS THE PRINCE EDWARD COUNTY MUSEUM, THE FORMER 'OLD' ST. MARY MAGDALENE CHURCH, CHURCH AND UNION STREETS IN THE TOWN OF PICTON, MORE PARTICULARLY DESIGNATED AS ALL OF LOTS 1230, 1231, 1232, AND 1246 ACCORDING TO THE R.W. HERMON REGISTERED PLAN NO. 24.

NOTICE OF INTENTION TO AMEND A BY-LAW DESIGNATING CERTAIN

TAKE NOTICE, that the Council of the Corporation of the County of Prince Edward intends to amend the designation of the following properties of architectural and historical interest under Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

THE PRINCE EDWARD COUNTY MUSEUM, THE FORMER 'OLD' ST. MARY MAGDALENE CHURCH, Church and Union Streets in the Town of Picton, more particularly designated as all of Lots 1230, 1231, 1232, and 1246 according to the R.W. Hermon Registered Plan No. 24.

The existing by-law which designates the Prince Edward County Museum, The 'Old' St. Mary Magdalene Church as a property of architectural and historical value will be amended to include all lands incorporating the cemetery of The 'Old' St. Mary Magdalene Church and, all grave stones, grave markers and iron railings located within the cemetery.

This request having been made by the Prince Edward County Museum Board has been reviewed by the Prince Edward County Local Architectural Conservation Advisory Committee and they have recommended that the Council of the County of Prince Edward consent to this request.

Prince Edward County Council adopted the report and recommendation of the Local Architectural Conservation Advisory Committee dated May 31st, 1989 at their regular meeting held on June 29th, 1989 thereby consenting to the Museum Board's request to amend the said by-law.

Any person may, within thirty days of the first publication of this notice send by registered mail or deliver to the Clerk of the County of Prince Edward notice of his or her objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the County of Prince Edward shall refer the matter to the Conservation Review Board for a hearing.
