

NOTICE OF INTENTION TO DESIGNATE
HERITAGE BUILDINGS

In the matter of the Ontario Heritage Act, R.S.O. 1980, chapter 337, part 4, and in the matter of the lands and premises known municipally as part lot 26, concession 5, in the Township of North Easthope, County of Perth.

NOTICE OF PASSING OF BY-LAW

Take notice that the Council of the Township of North Easthope of the Corporation of the County of Perth has passed By-law Number 19-92, to designate the lands and premises known municipally as Part of Lot 26, Concession 5, Township of North Easthope, as a property of architectural and historical value under the Ontario Heritage Act, chapter 29.

REASONS FOR PROPOSED DESIGNATION

Knox North Easthope Presbyterian Church Building is a good example of gothic church architecture. It is on the site of the original North Easthope Presbyterian Church building that was built in 1846, and maintained to have been the first brick Presbyterian Church building built west of Toronto. The site itself is the oldest church site in continuous use in North Easthope Township and one of the oldest in Perth County. The Knox North Easthope Presbyterian Church Site also has one of North Easthope's earliest pioneer cemeteries. This designation would cover the one acre site, the building's exterior and details, and the interior now altered as outlined in application submitted to council.

Any person who objects to the proposed designation shall, within thirty days of the first publication of this notice, deliver in writing to the Clerk of North Easthope notice of his or her objection.

BY-LAW NUMBER 19-92

OF THE

TOWNSHIP OF NORTH EASTHOPE

BEING a By-law to designate the property known municipally as the Knox North Easthope Presbyterian Church property, part lot 26, concession 5 as being of architectural value or interest.

WHEREAS Section 29 of the Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural value or interest; and

WHEREAS the Council of the Corporation of the Township of North Easthope has caused to be served upon the owners of the lands and premises known municipally as part lot 26, concession 5, and upon The Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;

THEREFORE the Council of the Corporation of the Township of North Easthope ENACTS AS FOLLOW;

- 1) There is designated as being of architectural value or interest the real property known municipally as the Knox North Easthope Presbyterian Church property, part lot 26, concession 5 more particularly described in Schedule "A" hereto.
- 2) The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the properties described in Schedule "A" hereto in the proper land registry office.
- 3) The Clerk is hereby authorized to cause a copy of this by-law to be served on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality.
