CORPORATION OF THE COUNTY OF PRINCE EDWARD

AS CARREST AND ASSESSMENT OF THE STATE OF TH

BY-LAW NUMBER 2179

A BY-LAW TO AMEND BY-LAW NO. 1804, being a By-law which designates certain properties in the County of Prince Edward as being of Architectural and/or Historical Value or Interest.

WHEREAS the property known as the (John) Demill/Foster/Jones House located in Part of Lot 26, Concession 1, West of Green Point, Township of Sophiasburgh, more particularly described as Part 1 on Reference Plan 47R-3845, was among the properties designated by By-law No. 1804 passed by County Council under authority of Section 29 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337;

AND WHEREAS the owner of the property, applied to and received consent from the Prince Edward County Land Division Committee to sever an approximate 5.68 acre parcel from the property, conditional on By-law No. 1804 being amended to exclude the severed parcel from designation;

AND WHEREAS the Local Architectural Conservation Advisory Committee, at their October 17, 1994 meeting, recommended to County Council that designating By-law No. 1804 be amended so as to accommodate the severance and County Council at its meeting held on October 27, 1994 adopted the recommendation of the Local Architectural Conservation Advisory Committee;

AND WHEREAS no objection to the proposed By-law has been served on the Clerk of the municipality;

NOW THEREFORE, UNDER THE AUTHORITY OF SECTION 31 OF THE ONTARIO HERITAGE ACT, R.S.O. 1980, CHAPTER 337, THE COUNCIL OF THE CORPORATION OF THE COUNTY OF PRINCE EDWARD enacts as follows:


- THAT By-law No. 1804 be amended to exclude the lands in the southeast corner of Lot 26, Concession 1, West of Green Point in the Township of Sophiasburgh, comprised of a total of approximately 5.68 acres, more particularly described as Part 1 on Reference Plan 47R-6120.
- THAT the Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of the property, and on the Ontario Heritage Foundation.
- THAT reference to the property be amended accordingly in the Municipal Register referred to in Section 27(1) of the Ontario Heritage Act R.S.O., 1980 Chapter 337.
- 4) THAT notice of this By-law be published in a newspaper having general circulation in the municipality, once for each of three consecutive weeks.

- 5) THAT the County Solicitor is hereby authorized to register a copy of this Bylaw against the real property both severed and retained as described in the foregoing in the Land Registry Office.
- 6) THAT in all other respects By-law No. 1804 remains in full force and effect.

THIS BY-LAW READ A THIRD TIME AND FINALLY PASSED at Picton, Ontario this 30th day of November, 1995.

TAKE NOTICE THAT the Council of the Corporation of the County of Prince Edward passed By-law No. 2179 on the 30th day of November, 1995 under the authority of Section 31 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337. By-law No. 2179 amends designating By-law No. 1804 to exclude approximately 5.68 acres of land with 450 feet of frontage on Water Road, situated in the southeasterly corner of the property, identified as part of Lot 26, Concession 1 West of Green Point in the Township of Sophiasburgh. The lands which have been excluded from designation are vacant and are more particularly described as Part 1 on Reference Plan 47R-6120.
