THE CORPORATION OF THE TOWNSHIP OF AMELIASBURGH

BY-LAW # 870/81

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS LOT 90, PLAN 2RM AND LOT 93, CONCESSION 1, AS BEING OF ARCHITECTURAL AND/OR HISTORICAL VALUE OR INTEREST.

WHEREAS section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Township of Ameliasburgh has caused to be served on the owners of the lands and premises known as

- (a) Lot 90 Plan 2RM, Township of Ameliasburgh
- S.S.# 12

The Old School at Ameliasburgh c:1890, is an essential part of the village epitomizing The Old Country School House.

- (b) Lot 93, Concession 1, Township of Ameliasburgh
- Albury Church

Albury Church is principally of note for the architectural composition of the exterior, its exterior details and materials and for the interior of the church proper and its finishes and furniture. The building is also historically significant for its non-denomination background.

at Lot 90, Plan 2RM and Lot 93, Concession 1, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;

THEREFORE the Council of the Corporation of the Township of Ameliasburgh enacts as follows:

- 1) There is designated as being of architectural and/or historical value or interest the real property known as

- (a) Lot 90, Plan 2RM, Township of Ameliasburgh
- S.S.# 12

- (b) Lot 93, Concession 1, Township of Ameliasburgh
- Albury Church

Albury Church is principally of note for the architectural composition of the exterior, its exterior details and materials and for the inte

ior of the church proper and its finishes and furniture. The building is also historically significant for its non-denomination background.

at Lot 90, Plan 2RM and Lot 93, Concession 1, more particularly described in schedule A hereto.

2) The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A hereto in the proper land registry office.

3) The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.
