

THE CORPORATION OF THE TOWNSHIP OF ERNESTOWN

BY-LAW 1004-88

A BY-LAW TO REPEAL BY-LAW #962-87 being a by-law to designate the Switzerville United Church as an historical property pursuant to Part IV of The Ontario Heritage Act, R.S.O. 1980, C. 337 as amended.

WHEREAS Part IV of The Ontario Heritage Act, C. 337 as amended, contains provisions relating to heritage conservation properties.

AND WHEREAS Council under By-law #962-87 has designated the Switzerville United Church and cemetery property as an historical property.

AND WHEREAS the Owners of the designated property requested a demolition permit from the Township on November 2nd, 1987.

AND WHEREAS at regular Council meeting held on January 25th, 1988, Council received and adopted the recommendation of its Local Architectural Conservation Advisory Committee and refused to issue the demolition permit.

AND WHEREAS continuing efforts by interested parties have failed to effect a purchase of the property.

AND WHEREAS the Owners reiterated their request for a demolition permit on July 27th, 1988 and in accordance with the requirements of Section 34(5) a demolition permit was issued and the demolition of the building has been completed.


NOW THEREFORE the Council of the Municipality of the Township of Ernestown enacts as follows:

By-law Number 962-87 is hereby repealed upon passing of this by-law.
