BY-LAW NUMBER 26 OF 1978

OF THE CORPORATION OF THE TOWN OF ST. MARYS

BEING a by-law to designate the property known municipally as Lot 1, Plan 225, Queen Street East as being of architectural value or interest.

WHEREAS Section 29 of the Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Town of St. Marys has caused to be served on the owners of the lands and premises known as the Water Tower at Lot 1, Plan 225, Queen Street East, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality:

THEREFORE the Council of the Corporation of the Town of St. Marys ENACTS AS FOLLOWS:

- 1) There is designated as being of architectural value or interest the real property known as the Water Tower at Lot 1, Plan 225, Queen Street East, more particularly described in Schedule A hereto.
- 2) The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A hereto in the proper land registry office.
- 3) The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having a general circulation in the municipality once for each of three consecutive weeks.

READ a first time this 25th day of July, 1978.

READ a second time this 25th day of July, 1978.

READ a third time and FINALLY PASSED this 25th day of July, 1978.

SCHEDULE A

The Water Tower was built in 1899 and is a solid stone structure which is representative of other stone buildings erected during this period in the Town of St. Marys. It is one of the best examples of industrial architecture constructed during the turn of the century in Southwestern Ontario and still in use.
