**NOTICE OF INTENT TO DESIGNATE**

**TAKE NOTICE** that the Council of the Corporation of the City of Sarnia intends to designate the curved exterior wall on the north side of the building, the cornice and dentil work around the exterior top of the building and the brick and stonework around the bottom exterior portion of the building, as being of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, R.S.O, 1990, c.O.18 as amended.

**PROPERTY:** LOCHIEL KIWANIS CENTRE AT 180 COLLEGE AVENUE NORTH,  
SARNIA

**REASONS FOR PROPOSED DESIGNATION**

The Lochiel Kiwanis Centre building is one of the oldest school buildings in our community. The site was home to three schools, old Lochiel Street School built in 1872 and demolished in 1924, George Street School, also known as The Model School, built in 1878 and demolished in 1937 (steel amalgam bell remains on the site and carries a heritage designation), and Lochiel Street School, built in 1916 and known as the Lochiel Kiwanis Centre. Sarnia Heritage Committee (LACAC) considers the curved exterior wall on the north side of the building, the cornice and dentil work around the exterior top of the building and the brick and stonework around the bottom exterior portion of the building, as being worthy for heritage preservation.

**NOTE:**

Any person may, within thirty days of the publication of this Notice, send by registered mail or deliver to the Clerk of the City of Sarnia, notice of his or her objection to the proposed designation, together with a statement of reason for the objection and relevant facts. If such Notice of Objection is received, the Council of the Corporation of the City of Sarnia shall refer the matter to the Conservation Review Board for hearing.
