BY-LAW NUMBER 70 OF 1994  
OF THE CITY OF SARNIA

"A By-Law to Designate the structure known municipally as the Ferry Dock Hill Lampposts, Sarnia, Ontario, as being of Historic or Architectural Value or Interest"

---

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, c. O.18, authorizes the Council of a municipality to enact By-Laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS the Municipal Council of The Corporation of the City of Sarnia has caused to be served on the owners of the Ferry Dock Hill Lampposts, Sarnia, Ontario, and upon the Ontario Heritage Foundation, notice of intention to designate the aforesaid Ferry Dock Hill Lampposts and has caused such notice of intention to be published in a newspaper having a general circulation in the municipality once for each of three consecutive weeks;

AND WHEREAS the reasons for designation are set out in Schedule "B" hereto;


AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality.


NOW THEREFORE the Municipal Council of The Corporation of the City of Sarnia enacts as follows:

1. There is designated as being of historic or architectural value or interest the real property more particularly described in Schedule "A" hereto, and known as the Ferry Dock Hill Lampposts.

2. The City Solicitor is hereby authorized to cause a copy of this By-Law to be registered in the proper land Registry Office against the lands described in Schedule "A" hereto, which are the lands affected by this By-Law.
3. The City Clerk is hereby authorized to cause a copy of this By-Law to be served upon the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of this By-Law to be published for each of three consecutive weeks in a newspaper having general circulation in the City of Sarnia.
4. This By-Law comes into force and effect upon being finally passed.

SCHEDULE "A"

DESCRIPTION

The Lampposts situated on the Ferry Dock Hill right-of-way, which Lampposts can be more particularly located as follows:

In the City of Sarnia, in the County of Lambton and Premising that the west side of Front Street has a bearing of N 23° 12' 30" E;

FIRSTLY:

Commencing at a point on the west side of Front Street at the northwest angle of the Ferry Dock Hill Right-of-Way over Part of Lot D, west side of Front Street, Plan 14 (SA);

Thence S 31° 51' 25" W 55.04 feet more or less to the centre point of the easterly most Lamppost.

SECONDLY:

Commencing at the aforesaid point in the west limit of Front Street;

Thence s 61° 35' 45" W 96.56 feet more or less to the centre point of the westerly most Lamppost.

SCHEDULE "B"

REASONS FOR DESIGNATION

These City-owned street light standards are recommended for designation for architectural reasons. Installed in the early 1920's, the lampposts are constructed of cast iron with acorn shaped glass refractors.
