NOTICE OF PASSING OF BY-LAW

TAKE NOTICE that the Council of the Corporation of the TOWN OF WHITBY has passed By-law 1436-82 to designate the following property as being of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act., R.S.O., 1980, Chapter 337:

a) Architectural

The Hood/Hare House is an excellent example of the vernacular Gothic Revival Style of architecture. The most outstanding feature of this white clapboard house is the finely detailed bargeboard and treillage work which surround the house. Also of interest are the transom and sidelights of leaded glass which surround the front door.

b) Historical

The Hood/Hare has had a number of owners since it was built in 1875, the most prominent of whom are:

Mr. William Hood who had the house built; and Mrs. Florence Metcalfe and Mrs. Kathleen Hare.

By-law Number 1436 -82

BEING A BY-LAW TO DESIGNATE THE STRUCTURE KNOWN MUNICIPALLY AS 301 CENTRE STREET SOUTH AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE AND INTEREST

WHEREAS Section 29 of The Ontario Heritage Act, 1980, R.S.O., Chapter 337, authorizes the Council of a municipality to designate property, as defined therein, to be of architectural and historical value and interest;

AND WHEREAS the Council of the Corporation of the Town of Whitby has caused to be served on the owners of the lands and premises known as 301 Centre Street South, Whitby, Ontario, and upon The Ontario Heritage Foundation, notice of intention to designate the structure at the aforesaid address and has caused such notice to be published in a newspaper having general circulation in the municipality;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality in accordance with the provisions of said Act;

NOW, THEREFORE, BE IT ENACTED AND IT IS HEREBY ENACTED as a By-law of the Corporation of the Town of Whitby by the Council thereof as follows:

- 1. That the exterior of the property known as The Hood/Hare House at 301 Centre Street South, Whitby, Ontario, more particularly described in Schedule 'A' hereto attached, be and the same is hereby designated as being of arhitectural and historical value and interest in accordance with the provisions of The Ontario Heritage Act, 1980, R.S.O., Chapter 337. This designation shall not preclude any changes that may be deemed necessary for the efficient use of the building provided that any and all changes shall be in keeping with the original and present character of the building and are carried out in consultation with the Local Architectural Conservation Advisory Committee for the Town of Whitby.
- That the municipal solicitor is hereby authorized to cause a copy of this By-law, together with the reasons for designation, to be registered against the aforesaid property in the proper land registry office.
- 3. That the Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of the aforesaid property and on The Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in a newspaper having general circulation in the municipality once for each of three consecutive weeks.
