NOTICE OF INTENT TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Whitby intends to designate the property, including lands and buildings at the following municipal address as property of architectural value or interest under Part 4 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

The Shier-Willis House 800 Centre Street South Whitby, Ontario

REASONS FOR DESIGNATION OF THE SHIER-WILLIS HOUSE

(a) Architectural

The Shier-Willis House is a good example of Ontario vernacular cottage design. It displays many architectural elements typical of its time including a simple yet elegant veranda trimmed with treillage, a panelled door with cut glass, sidelights and wooden shingles.

(b) Historical

The house was built in 1868 for John Shier, the first county engineer for Ontario County. He drew up Perry's and Werden's Plans upon which much of the older part of Whitby was built, and designed "Inverlynn" and "Perry's Castle". James Willis owned the house from 1901 until his death in 1938. Willis was a local businessman who held several public positions including that of Mayor from 1913-1914.

Any person may, before November 25, T983, send by registered mail or deliver to the Clerk of the Town of Whitby notice of his or her objection to the proposed designation together with a statement of reasons for the objection and all relevant facts. If such a notice of objection is received, the Council of the Corporation of the Town of Whitby shall refer the matter to the Conservation Review Board for a hearing.
