



NOTICE OF INTENT TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Whitby intends to designate the property, including lands and buildings at the following municipal address as property of architectural value or interest under Part 4 of the Ontario Heritage Act, R.S.O. 1980, c. 337.

208 Byron Street South  
Whitby, Ontario

REASONS FOR DESIGNATION OF 208 BYRON STREET SOUTH

Historical

The house was built as a private residence in 1868. In 1882, it was purchased as the rectory for All Saints' Anglican Church. It served in that capacity through 69 years and 9 successive Ministers. In 1951, the house reverted back to a private residence for which it has since been used.

Architectural

Much of the beauty of this building is presently hidden. The original tongue-in-groove frame siding and the window trim have been covered over by vinyl siding. The enclosed porch and the widow's walk have been removed and the two main-facade, first-floor windows have been enlarged. The roof trim treatment, particularly the cornice and brackets, are still in tact. With careful restoration, many of the significant architectural features will again become visible to the passer-by.

Any person may, before April 20, 1984, send by registered mail or deliver to the Clerk of the Town of Whitby notice of his or her objection to the proposed designation together with a statement of reasons for the objection and all relevant facts. If such notice of objection is received, the Council of the Corporation of the Town of Whitby shall refer the matter to the Conservation Review Board for a hearing.
