REASONS FOR DESIGNATION OF 60 QUEEN STREET, BROOKLIN

Historical

The house was built in 1868 by Alexander Campbell. He is believed to be the original operator of the Brooklin Mill.

Architectural

Although the house is of no particular architectural style, it is in the vernacular late Victorian tradition using such elements as peaked gables, bargeboard, open verandahs and bay windows. The house is well preserved and retains much of its original detailing.

Any person may, before February 7, 1986, send by registered mail or deliver to the Clerk of the Town of Whitby notice of his or her objection to the proposed designation together with a statement of reasons for the objection and all relevant facts. If such notice of objection is received, the Council of the Corporation of the Town of Whitby shall refer the matter to the Conservation Review Board for a hearing.
