

BY-LAW # 99-21

Being a By-Law to designate the property known Municipally as the Rockingham Church in Part Lot 32, Concession IX in the Geographic Township of Brudenell, designated as Part 2 on Plan 49R-13224, #519 Rockingham Road, as being of Architectural and historical value and interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

**WHEREAS** section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and


**WHEREAS** the Council of the Corporation of the Township of Brudenell, Lyndoch and Raglan has caused to be served on the owners of the lands and premises known as the Rockingham Church at #519 Rockingham Road, designated as Part 2 on Plan 49R-13224 and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

**WHEREAS** no notice of objection to the proposed designation has been served on the clerk of the municipality;


**THEREFORE** the Council of the Corporation of the Township of Brudenell, Lyndoch and Raglan enacts as follows:


1. There is designated as being of architectural and historical value and interest the real property known as the Rockingham Church at #519 Rockingham Road, more particularly described in Schedule 'A' attached hereto.
2. The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule 'A' attached hereto, in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the Barry's Bay - This Week newspaper having general circulation in the municipality once for each of three consecutive weeks.
