NOTICE OF PASSING BY-LAW

TAKE NOTICE that the Council of the Corporation of
the Township of Prince has passed by-law number 86-12
to designate the following property as being of historical
value or interest under Part IV of The Ontario Heritage
Act, 1980, Chapter 337:

Address of Property - 3042 Second Line West
Township of Prince

Reason for Proposed Designation

The building was constructed in 1883 as a United Church.
It was closed in 1968 and is the oldest building in the
Municipality of the Township of Prince . It has been used
as a museum since 1983.

CORPORATION OF THE TOWNSHIP OF PRINCE

BY-LAW 86-12

A by-law to designate the property
known as 3042 Second Line West (Museum)
as being of historical value or interest

WHEREAS Section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Township of Prince has caused to be served on the owners of the lands and premises known as the Township of Prince and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and


WHEREAS no notice of objection to the proposed designation has been served on the clerk of the municipality:

THEREFORE the Council of the Corporation of the Township of Prince enacts as follows:

- (1) There is designated as being of historical value or interest the real property known as the Prince Township Museum at 3042 Second Line West, more particularly described in Schedule A hereto.
- (2) The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A hereto in the proper land registry office.
- (3) The Clerk is hereby authorized to cause a copy of this by-law to be served on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

READ A FIRST, SECOND AND THIRD TIME and **FINALLY PASSED**

in Open Council this 8th day of July, 1986.
