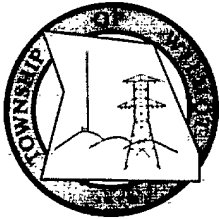

SCHEDULE TO A DOCUMENT GENERAL  
THE CORPORATION OF THE TOWNSHIP OF WILMOT

BY-LAW NO. 85-62

BY-LAW TO DESIGNATE CASTLE  
KILBRIDE IN THE TOWNSHIP OF  
WILMOT TO BE OF HISTORIC AND  
ARCHITECTURAL VALUE OR  
INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, C. 337, authorizes Council of a municipality to designate property within the municipality to be of historic or architectural value or interest;

AND WHEREAS Council for The Corporation of the Township of Wilmot deems it desirable to designate Castle Kilbride to be of historic and architectural value or interest;

AND WHEREAS the Clerk of the Township of Wilmot has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, R.S.O. 1980, C. 337;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of The Ontario Heritage Act, R.S.O. 1980, C. 337.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WILMOT ENACTS AS FOLLOWS:

1. The property described in Schedule "A" attached hereto is hereby designated to be of historic and architectural value and interest.
2. Section 33(1) of The Ontario Heritage Act, R.S.O. 1980, C. 337 shall apply only to the following:
  - (a) the entire front and east elevations of the building, including the porches,

the belvedere, the inlaid stone, circular drive and former outhouse.

- (b) the interior details of painting of the ceiling and wall, fireplaces and woodwork in the hallway on both floors, the library, smoking room, parlour, dining room, the nursery, and the front and rear interior staircases.

3. This By-law shall come into effect on the final passing thereof by the Council of the Corporation of the Township of Wilmot.

SCHEDULE "A"

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Township of Wilmot, in the Regional Municipality of Waterloo and being composed of Parts of Lots Numbers 14 and 15, North of Snider's Road, more particularly described as PARTS 1, 2, 3, 4, 5, 6 and 8 according to Reference Plan 58R-2347.

SUBJECT TO an easement over said Lot 15, being PART 1 according to Reference Plan Number 58R-2347, in favour of Ontario Hydro registered as Instrument Number 414465 and further SUBJECT TO a right-of-way over said Lot 14, being PARTS 6 and 8 according to Reference Plan Number 58R-2347.
