NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Township of Wilmot intends to designate the property at the following municipal address as a property of historic and architectural value under Part IV of the Ontario Heritage Act, R.S.O., 1980, Chapter 337.

> The subject property is located at 169 Front Street, New Dundee, Ontario; Familiarly known as "THE FMPORIUM", and is owned by
> It is intended that in particular, the entire exterior, including cornice and storefront details, as well as all elevations, be designated. The designation described herein is recommended on historic and architectural grounds. Mr. Gottlieb Bettschen, a prominent local citizen and inventor, has this store, then the Jubilee Block, built in 1887. J. U. Clemens, a prominent New Dundee and Kitchener merchant was the first to occupy the store. Herman Kavelman, long time operator of the store was also a prominent citizen, serving long terms as village librarian and fire chief. In terms of architecture, the building is an excellent example of late Victorian mercantile style, with its prominent bracketed cornice detailing. ______

Any person may, within thirty days of the first publication of this notice, send by registered mail, or deliver to the Clerk of the Township of Wilmot, notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Township of Wilmot shall refer the matter to the Conservation Review Board for a hearing.
