

THE CORPORATION OF THE TOWNSHIP OF WILMOT

BY-LAW NO. 87-59

BY-LAW TO DESIGNATE THE PROPERTY
LOCATED AT 98 PEEL STREET,
NEW HAMBURG, IN THE
TOWNSHIP OF WILMOT, TO BE OF
HISTORIC AND ARCHITECTURAL VALUE AND
INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act,
R.S.O. 1980 authorizes Council of a municipality to
designate property within the municipality to be of
historic value or interest;

AND WHEREAS Council for The Corporation of the
Township of Wilmot deems it desirable to designate the
property located at 98 Peel Street, New Hamburg, to be of
historic and architectural value and interest;

AND WHEREAS the Clerk of the Township of Wilmot
has caused Notice of Intention to Designate to be given in
accordance with Section 29(3) of The Ontario Heritage Act,
R.S.O. 1980;

AND WHEREAS no Notice of Objection has been
served on the Clerk within the meaning of Section 29(5) of
The Ontario Heritage Act, R.S.O. 1980.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE
CORPORATION OF THE TOWNSHIP OF WILMOT ENACTS AS FOLLOWS:

1. The property described in Schedule "A" attached hereto
is hereby designated to be of historic and
architectural value and interest.

2. Section 33 of The Ontario Heritage Act, R.S.O. 1980 shall apply only to the front facade with its stone balustrade, entablature, pilaster and window detailing.
3. This By-law shall come into effect on the final passing thereof by the Council of The Corporation of the Township of Wilmot.

DESCRIPTIONSCHEDULE "A"98 Peel Street
New Hamburg

IN the Regional Municipality of Waterloo and Province of Ontario, being composed of Part of Lot Number 27, on the West side of Peel Street known as Smith's Plan in what was formerly the Village of New Hamburg, according to the map or plan of the said Village dated the 1st day of April, 1876, more particularly described as follows:

COMMENCING at a point in the southwest limit of Peel Street distant forty-one (41.00') feet north thirty-eight degrees eighteen minutes west (N 38° 18' W) therealong from the southeast angle of Lot Number 27;

HENCE south fifty-one degrees forty-two minutes west (S 51° 42' W) thirty-six and eight tenths (36.8') of a foot to a point;

HENCE north thirty-eight degrees eighteen minutes west (N 38° 18' W) seventeen and five tenths (17.5') of a foot to a point;

HENCE north sixty-three degrees three minutes thirty seconds east (N 63° 03' 30" E) thirty-seven and three tenths (37.3') of a foot to a point in the southwest limit of Peel Street located fifty-one and eightythree one-hundredths (51.83') of a foot north thirty-eight degrees eighteen minutes west (N 38° 18' W) therealong from the southeast angle of Lot Number 27;

HENCE south thirty-eight degrees eighteen minutes east (S 38° 18' E) along the southwest limit of Peel Street ten and eighty-three one-hundredths (10.83') of a foot to the point of commencement.
