BY-LAW NO. 14-83

A By-Law to designate the property, including lands and structure known municipally as the swinging bridge as being of historical value or interest. (Swinging Bridge)

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Councils of municipalities to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural and/or historical value or interest; and

WHEREAS the Council of the Corporation of the Town of Renfrew has caused to be served on the owners of the property known as the "swinging bridge" located on the Raglan Street road allowance and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

 $\underline{\text{W H E R E A S}}$ no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE the Council of the Corporation of the Town of Renfrew enacts as follows:

- 1) There is designated as being of historical value or interest the real property known as the "swinging bridge" located on the Raglan Street road allowance more particularly described in Schedule "A" hereto.
- 2) The Municipal Solicitor is hereby directed to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the Land Registry Office.
- 3) The Clerk is hereby directed to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

4) That every person who contravenes any of the provisions of this By-Law or of the Ontario Heritage Act, R.S.O. 1980, Chapter 337, as amended, or regulations thereunder, is guilty of an offence and on summary conviction is liable to a fine not to exceed the maximum penalty establishel by said Act and amendments thereto.

ADDENDUM TO BY-LAW NO. 14-83 OF THE TOWN OF RENFREW

REASONS FOR DESIGNATION OF PROPERTY KNOWN MUNICIPALLY AS THE SWINGING BRIDGE AND MORE PARTICULARLY DESCRIBED IN SCHEDULE "A" to BY-LAW NO. 52-82:

In the year 1895 at the Second Chute of the Bonnechere River and at the foot of the Town's mainstreet a bridge was constructed of page woven coil spring wire. That bridge being the predecessor of the "swinging bridge". The swinging bridge is historically significant as a reminder of the Town's early development, particularly that adjacent to and north of the river. It is evidence of the early history of the town when the economy was based upon those riverside industries constructed under the progressive policies of Sir Francis Hincks. In the period 1850 to 1860 in close proximity to the bridge J.L. McDougall built his fine stone grist mill; John McRae built the wooden grist mill; William Logan built his woolen factory; Samuel Francis built his axe factory and Sir Francis (through his agent William McKay) constructed a saw mill as well as a number of other large buildings.

The old wire bridge was constructed by a few of the townsfolk at their own expense to serve the workers of the waterfront industries as well as the area residents. Residential development north of the river could also be attributed to Sir Francis, as he had laid down a plan for that part of the former village.

With the old wire bridge in a state of disrepair and the tragic loss of a life in 1913 the wire bridge was replaced by the swinging bridge designed by the Town Engineer Mr. J.R. Stewart and constructed by Mr. James McNicol. This historic swinging bridge, although altered slightly over the years, is certainly a unique reminder of our past.
