# THE CORPORATION OF THE CITY OF PORT COLBORNE

BY-LAW NO. 5357/111/09

BEING A BY-LAW TO DESIGNATE THE DOAN CEMETERY, MUNICIPALLY KNOWN AS 2146 SECOND CONCESSION, IN THE CITY OF PORT COLBORNE, AS BEING OF CULTURAL HERITAGE VALUE OR INTEREST

**WHEREAS** Section 29 of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of cultural heritage value or interest;

AND WHEREAS, the Council of the Corporation of the City of Port Colborne desires has caused to be served on the owners of the lands and premises at 2146 Second Concession and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the municipality;

**AND WHEREAS** no notice of objection to the proposed designation has been served on the Clerk of the municipality;

**NOW THEREFORE,** and pursuant to the provisions of Section 34 of The Planning Act, R.S.O. 1990, the CORPORATION OF THE CITY OF PORT COLBORNE ENACTS AS FOLLOWS:

1. That the property at 2146 Second Concession, in the City of Port Colborne, more particularly described in Schedule A attached hereto is designated as being of architectural and historical value.

2. The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A in the

proper land registry office.

3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Trust and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the municipality.

#### **SCHEDULE A**

#### **Reasons for Designation**

#### **Property Description**

The property is located in the City of Port Colborne, in the Regional Municipality of Niagara and being composed of part of Lot 16 Concession III, former Humberstone Township and part of the Original Crown Patent awarded to United Empire Loyalist Aaron Doan on May 17, 1802. It is municipally known as 2146 Second Concession Road. The site name should be officially recognized as the "Doan / Steele's Cemetery".

#### Elements to be Designated

The basic foot print of the cemetery being approximately 150 feet along 2<sup>nd</sup> Concession and 103 feet in depth.

The various tombstones, dating back to the 1844's and earlier.

In addition, their significance in that some of them were United Empire Loyalist, further increases this significance, as this site and the markers that still adorn it, are a reminder and marker of our history.
