NOTICE OF INTENTION TO DESIGNATE

Take notice that the Council of the Corporation of the Township
of Saugeen intends to designate the property, including lands
and structures, at the following municipal address as a
Property of Historical Value or Interest under Part IV of The
Ontario Heritage Act, 1974, S.O. Chapter 122.

THE OLD SOUTHAMPTON CEMETERY
Saugeen Street
Township of Saugeen.

REASON FOR DESIGNATION: This burial site dating back to
1860 marked the final resting place of many of the early
settlers of the Southampton area who made their way to
this part of Bruce County and started a Heritage and Family
beginning for many of the residents who live here today some
120 years later.

Any person may, within thirty days of the first publication
of this Notice, send by Registered Mail or deliver to the
Clerk of the Corporation of the Township of Saugeen, Notice
of his or her objection to the proposed designation together
with a statement of the reasons for the objection and all
relevant facts. If a Notice of Objection is received, the
Council of the Corporation of the Township of Saugeen shall refer
the matter to the Conservation Review Board for a Hearing.
