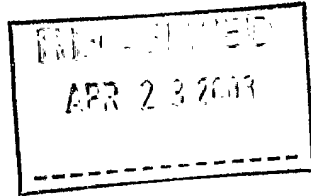

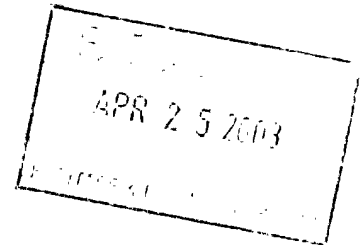

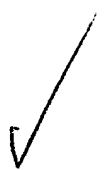

TAKE NOTICE that the Council of the Corporation of the Town of Whitby intends to designate the property, including the lands and building at the following municipal address as property of historical and architectural value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, c. 0.18.

**REASON FOR DESIGNATION OF 604 BROCK STREET SOUTH, WHITBY**

**Historical & Architectural**

Its architectural significance lies not in its landmark status, but in its simple relation to its historical context and to its environment. With neighbouring buildings, this house is a fine example of the mid-nineteenth century style of architecture of Whitby. The Westlake House has been maintained in good condition and it reflects its original design.

This house was constructed in the mid 1880's by William Westlake, a local builder who was the first resident of the house. His daughter, Daisy Susan Westlake married Roy Talling, a clothing merchant in downtown Whitby. Recently, the home has belonged to the [REDACTED] of Whitby.

Any person may, before May 23, 2003 send by registered mail or deliver to the Clerk of the Town of Whitby, notice of his or her objection to the proposed designation together with a statement of reasons for the objection and all relevant facts. If such a notice of objection is received, the Council of the Corporation of the Town of Whitby will refer the matter to the Conservation Review Board for a hearing.
