The Lynde House - 300 Taunton Road West and the Request to Repeal Heritage Designation By-law No. 3097-92

Please be advised of our intention to repeal By-law No.'s 6404-10 and 6405-10 as noted above, located at 300 Taunton Road West, Whitby, Ontario, in order to facilitate the sale of lands from the municipality to Le Nordik Nature Spa and permit the potential relocation of the buildings within the same lands known municipally as 300 Taunton Road West, Whitby; save and except the repeal of By-law No. 3097-92, which will facilitate the relocation of the Lynde House from 300 Taunton Road West to the municipally owned lands at 900 Brock Street South. After the building's relocation, the heritage attributes of the Lynde House, which are currently recognized through By-law No. 3097-92, will be reinstated through designation at 900 Brock Street South under Part IV of the Ontario Heritage Act.

Notice of Intention To Remove a Heritage Designation

This will serve as Notice to Repeal By-law No. 6404-10, Being a By-law To Designate the Jones Puckrin House on the property municipally known as 300 Taunton Road West under the Ontario Heritage Act.

Take notice that the Council of the Corporation of the Town of Whitby hereby resolves to issue a Notice of Intention to Repeal By-law No. 6404-10, which designated Part Lot 28, Concession 4, Township of Whitby, Part 1, Plan 40R-26574 in the Town of Whitby, in the Regional Municipality of Durham, known as the Log Cabin Emporium at 300 Taunton Road, under Section 29 of the Ontario Heritage Act, R.S.O. 1990, c.18, as a property of cultural heritage value and interest.

The reason for repeal of By-law No. 6404-10 is to facilitate the sale of lands from the municipality to Le Nordik Nature Spa and permit the potential relocation of the building within the same lands known municipally as 300 Taunton Road West, Whitby.
