CORPORATION OF THE TOWN OF PARIS

BY-LAW NUMBER 2569

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS 22 CHURCH STREET, PARIS AS BEING OF ARCHITECTURAL AND/OR HISTORICAL VALUE OR INTEREST

WHEREAS section 29 of The Ontario Heritage Act, R.S.O. 1980 authorized the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS the Council of the Corporation of the Town of Paris has caused to be served on the owners of the lands and premises at 22 Church Street and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks;

AND WHEREAS the reasons for designation are set out in Schedule "B" hereto;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;

THEREFORE the Council of the Corporation of the Town of Paris enacts as follows:

- 1. There is designated as being of architectural and/or historical value or interest the real property at 22 Church Street, more particularly described in Schedule A hereto.
- 2. The municipal Clerk is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A hereto in the proper land registry office.
- 3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

READ A FIRST TIME this 28th day of August 1984. READ A SECOND TIME this 28th day of August 1984. READ A THIRD TIME AND FINALLY PASSED this 28th day of August 1984.

ALL and Singular that certain parcel or tract of land and premises, situate, lying and being in the Town of Paris, in the County of Brant being composed of that part of Lot Number 8 in Block 40 according to Plan 492, designated as Part 2 on the Plan deposited in the Land Registry Office for the Land Registry Division of Brant (No. 2) as Number 2R-1877.

Architectural

- one of the finest examples of cobblestone construction in the Town (two exterior walls)
- remaining side and back wall in fieldstone
- front porch or portico, shutters and all exterior wood work are basically in original state
- original windows, but the roof has been shingled over its original roof of wooden shakes

Historical

- home constructed between 1842 and 1845
- believed to be built by Levi Boughton

- Alexander Graham Bell and his parents were guests here of Reverend Henderson, while their own home in Brant was being constructed.
