NOTICE OF INTENTION
TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Smiths Falls intends to designate the building, being the former Canadian National Railway Station as a building of architectural and historic value or interest under Part IV of The Ontario Heritage Act, Chapter 337, R.S.O. 1980.

This building is situated on lands adjacent to William Street being comprised of Block AV and AT and part of Church Street closed, Registered Plan 2857 and shown as Canadian National Railway land on Registered Plan 13884 of the Town of Smiths Falls.

[The building is a fine example of a typical Eastern Canadian Railway Station both from its exterior architectural and interior design aspects. The purpose of this designation is to preserve an example of this type of architecture and historical significance.]

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Town of Smiths Falls notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Town of Smiths Falls shall refer the matter to the Conservation Review Board for a hearing.
