## The Corporation of the Town of South Bruce Peninsula

By-Law Number 48-2015

Being a By-Law to De-Designate as Having Historic or Architectural Value or Interest Pt Lt 1-2 Pl 304 as in R346791

Whereas the Council of the Corporation of the Village of Hepworth did pass a by-law in July of 1989 designating the property described in Schedule A of this by-law in accordance with Sub-section 29 6(a) of the Ontario Heritage Act 1980;

And whereas the notice provisions outlined in the Act were not completed in accordance with the Act:

And whereas the Town of South Bruce Peninsula does so desire to de-designate the property as described in Schedule A to this by-law in accordance with Section 31 of the Ontario Heritage Act, 1990.

# Now therefore the Council of the Corporation of the Town of South Bruce Peninsula enacts as follows:

- 1. That the property known as 513 Bruce Street, former Village of Hepworth, now in the Town of South Bruce Peninsula and more particularity described in Schedule A attached hereto, is hereby de-designated and the by-law adopted by the Corporation of the Village of Hepworth on July 26, 1989 indicating that the property has historic or architectural value or interest is hereby repealed.
- That this by-law shall not be required to be registered on the title of the property described in Schedule A attached hereto (unless so requested by the Ontario Heritage Trust) as the original by-law was not registered on the title of the property.
- 3. That the Clerk is hereby authorized and directed to cause a copy of this by-law, together with a statement explaining the de-designation of the property to be served on the owner of the property and on the Ontario Heritage Trust by personal service or by registered mail.
- 4. That the Clerk is hereby authorized and directed to publish a notice of this by-law once in the Sun Times.
- 5. That this by-law shall come into force and effect upon the final passing thereof.

Read a first and second time this 21st day of April, 2015.
