## THE CORPORATION OF THE TOWNSHIP OF CHARLOTTENBURGH

IN THE MATTER OF THE ONTARIO HERITAGE ACT, R.S.O. 1980 Chapter 337 as amended and in the matter of the premises (house) on Concession 1 NRR, N/E Part Lot 38, south side County Road 18 (King's Road South, McCuaig's Corners) in the Township of Charlottenburgh in the Province of Ontario.

### NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Township of Charlottenburgh intends to designate the property (house) on Concession 1 NRR, N/E Part Lot 38, south side County Road 18 (King's Road South, McCuaig's Corners) as a property of architectural and/or historical value and interest under Part IV of The Ontario Heritage Act, R.S.O. 1980 Chapter 337.

#### Reasons for Proposed Designation

The stone farmhouse dates from 1825. Plain and rectangular in form, it is an excellent example of early 19th century rural vernacular domestic architecture in Eastern Ontario. The random coursed, roughly squared and split fieldstone of the elevations is typical of the Regency period. Of particular interest is the arched stonework of the lintels above windows and transom. This aesthetic feature characterises the stone masonry skills of the period.

Any person may, before Tuesday, April 13, 1993 send, by registered mail or deliver to the Clerk of the Township of Charlottenburgh, notice of objection to the proposed designation together with a statement of the reasons for the objection, and all relevant facts. When a Notice of Objection has been received, the Council of the Township of Charlottenburgh will refer the matter to the Conservation Review Board for a hearing and report.
