

THE CORPORATION OF THE TOWNSHIP
OF CHARLOTTENBURGH
BY-LAW NUMBER 60-85

BEING A BY-LAW TO DESIGNATE A PARCEL OF LAND
AND STRUCTURE THEREUPON UNDER THE HERITAGE
ACT, CHAPTER 337 RSO 1980, AS AMENDED.

WHEREAS the Council of the Township of Charlottenburgh is
desirous of designating Lot 19 & 20, Plan 19, as a Heritage
building having a heritage and historical value due to the
architectural nature of construction, the period of construc-
tion and the heritage supplied by the Museum.

THEREFORE BE IT RESOLVED and it is herewith resolved that Lot
19 & 20, Plan 19, being owned by the Corporation of the Township
of Charlottenburgh and occupied as by the Nor-Westerns' Museum,
be and is hereby designated a heritage building having heritage
and historical value under the Ontario Heritage Act, Chapter
337 RSO 1980.
