THE CORPORATION OF THE TOWNSHIP OF SOUTH DUMFRIES

BY-LAW 78-91

Being a by to designate the St. George Community Memorial Hall at 34-36 Main St. South St. George as being of Architectural and Historical Value and Interest.

WHEREAS Section 29 of The Ontario Heritage Act Chapter 337 R.S.O. 1980 authorizes the council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest; and

WHEREAS the Council of the Corporation of The Township of South Dumfries has served upon The Ontario Heritage Foundation to designate 34-36 Main Street South St. George Ontario and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of municipality.

NOW THEREFORE the Council of The Corporation of The Township of South Dumfries enacts as follows:

- 1) There is designated as being of architectural and historical value and interest the real property, known as the St. George Community Memorial Hall at 34-36 Main Street South St. George, Ontario more particularly described in Schedule A hereto.
- 2) The Municipal Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule A hereto in the proper Land Registry Office.
- 3) The Clerk is hereby authorized to cause a copy of this By-Law to be served on the owner of the aforesaid property and on The Ontario Heritage Foundation and to cause notice of the passing of this By-Law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

Read a first and second time this 19th day of November 1991.

Read a third time and finally passed this 19th day of November 1991.
