## RE: Lakewood Golf Club 13451 Riverside Drive Notice of Withdrawal of Notice of Intention to Designate Under Part IV, Section 29, of the *Ontario Heritage Act*

The Council of the Town of Tecumseh at their meeting held on Tuesday, April 14, 2009, gave consideration to matters relating to the proposed designation of Lakewood Golf Course under Part IV, Section 29, of the Ontario Heritage Act.

At the meeting, the members passed the following motion:

"WHEREAS at its meeting on March 24, 2009, the Council of the Town of Tecumseh passed resolution RCM-101/09 withdrawing the Notice of Intention to Designate under Part IV, Section 29 of the *Ontario Heritage Act*, the property legally described as Parts 1-3, 5-10, and 14-19 on Registered Plan 12R-15622, Concession West Pike Creek, Part Gore Lot, in the Town of Tecumseh, in the County of Essex and Province of Ontario, municipally known as 13451 Riverside Drive East (Lakewood Golf Club), notice of which was served on the Owner, March 6, 2008 and published in the Windsor Star on March 7, 2008;

**AND WHEREAS** on March 26, 2009, Sumatara Investments Ltd. withdrew its Notice of Objection, pursuant to subsection 29(15) of the *Ontario Heritage Act*, which further requires Council to deal with the Notice of Intention to Designate;

**NOW THEREFORE** be it resolved that the Council of the Town of Tecumseh confirms the withdrawal of the Notice of Intention to Designate the property legally described as Parts 1-3, 5-10, and 14-19 on Registered Plan 12R-15622, Concession West Pike Creek, Part Gore Lot, in the Town of Tecumseh, in the County of Essex and Province of Ontario, municipally known as 13451 Riverside Drive East (Lakewood Golf Club), pursuant to section 29(6)(b) of the *Ontario Heritage Act*, and directs that notice be given pursuant to the Act.
